

**RESOLUTION NO. 123-2017**

**RESOLUTION APPROVING THE MEMORANDUM  
EXTENDING AGREEMENT BETWEEN THE TOWNSHIP  
OF GREENWICH AND THE POLICEMEN'S  
BENEVOLENT ASSOCIATION, LOCAL #122**

**WHEREAS**, members of the Township of Greenwich Police Department are represented by the New Jersey State Policeman's Benevolent Association ("PBA") Local #122; and

**WHEREAS**, the existing collective negotiation agreement between the Township of Greenwich and PBA Local #122 expired on December 31, 2016; and


**WHEREAS**, the Township of Greenwich and representatives of PBA Local #122, have agreed to extend the Agreement for an additional year through December 31, 2017, subject to the terms and conditions of the Memorandum Extending Agreement, attached as Schedule A; and

**WHEREAS**, the Administrative Assistant for the Mayor and Labor Counsel have recommended approval of the Memorandum Extending Agreement, attached as Schedule A, which is available for public inspection and review.



**Memorandum Extending Agreement  
between  
Township of Greenwich  
and  
New Jersey State Policemen's Benevolent Association, Local #122**

The Township of Greenwich and PBA Local #122 are parties to a collective negotiation agreement ("Agreement") with an expiration date of December 31, 2016.


The parties agree to extend the Agreement for an additional year through December 31, 2017, subject to the following change:

Article V (Probationary Period; Wages) is amended as follows:


6. The base salary of all patrolmen, sergeants, detectives and lieutenants shall be increased by two percent (2%) for 2017, retroactive to January 1, 2017. Salaries in this schedule do not reflect longevity which will be incorporated into the base salary of those employees who are entitled as per Article V, Section 8 of this Agreement.

Except as modified above, all other terms and conditions of the Agreement remain unchanged and continue in effect.



