BE IT FURTHER RESOLVED, that the Mayor and Council hereby ratify and confirm any and all actions taken by the appropriate officials in the past with respect to the subject negotiations; and

BE IT FURTHER RESOLVED, that the Certificate of Availability of Funds pursuant to N.J.S.A. 40A:4-57 has been certified to by the Chief Finance Officer and is attached hereto and made a part hereof.



2010 Contract Amendment Proposal to PBA & SOA Local 313
November 19, 2010

- All officers contribute 1.5% of salary (pre-tax deduction) for healthcare starting 1-1-2011.
- All officers employed by the Borough as of 1-1-2011 will receive a 1% increase in their eligible longevity rate beginning on 7-1-2013.
- Borough will refund the dollar value of the total healthcare contributions made by any officer who retires, or otherwise separates, from the Borough prior to expiration of the present contracts.
- All other provisions of the present contracts remain intact.
- The respective negotiating committees recommend ratification to their constituencies.
- The above provisions are subject to ratification by the members of PBA & SOA Local 313 and the Wood-Ridge Borough Council.
