MEMORANDUM OF AGREEMENT BRTWEEN THE CITY OF NEWARK

AND

police superior officers' association of Newark, Inc.

The negotiation committees of the City of Newark ("City") and Newark Police Superior Officers' Association ("Association") hereby agree to resolve the collective negotiations agreement commencing January 1, 2016 through December 31, 2017 by recommending the following terms and conditions to the full union membership and to the Municipal Council for nuilication.

All terms and conditions of the existing contract that are not modified by those contained in this Memorandum of Agreement shall remain in full force and effect.

This Memorandum of Agreement shall be subject to ratification by the majority of the union membership, adoption by the Newark Municipal Council and approval by the State of New Jersey Department of Community Affairs. The negotiations committees shall recommend the ratification of the terms of this Memorandam of Agreement to their respective constituents.

Upon ratification by both parties, the following terms and conditions contained in this Memorandum and all tentative agreements shall be incorporated into a successor collective regolistions agreement.

ARTICLE V HOURS OF WORK AND OVERTIME

SECTION I:

(c) Upon full execution of this collective negatiations agreement, each Superior Officer who is assigned to the District Desk, the Central Communications Dispatch Operations Supervisor (floor operations), excluding administrative supervisory personnel, and the Prisoner Processing Section Supervisor (Cell Block area), excluding administrative supervisory personnel, shall be granted a functi break not to exceed forty (40) minutes during his/her tour of duty. This break shall be taken as near to the midpoint of the officer's tour of duty as possible, provided that the affected officer remains in the building and within sight of his/her duty station in case an emergency situation arises which requires his/her immediate attention.

ARTICLE XXVIII

WAGES

Upon execution of this Collective Negotiations Agreement, the wages shall be paid to all employees covered by this Agreement and shall be retroactive to the date of the Agreement in accordance with Appendix B attached hereto and made a part hereof.

Effective January 1, 2016, there shall be a one percent (1%) increase over the 2015 base salaries of all employees covered by this Agreement.

Effective Junuary 1, 2017, there shall be no increase in the base satary of all employees covered by this Agreement.

All current language in Appendix B of this Article that is inconsistent with these provisions shall be eliminated from the agreement.

ARTICLE XXX DURATION

Section 1. This Agreement shall be in full force and effect us of January 1, 2015 and shall remain in offeet up to and including December 31, 2017 without any reopening date.
