WHEREAS, the County and the Union are parties to a Memorandum of Agreement which was adopted on July 9, 2014 for a term of four (4) years, January 1, 2014 through December 31, 2017;

WHEREAS, the County and Union have reached agreement that all full time members employed by the County earning less than fifteen dollars (\$15) per hour shall now be paid a wage of fifteen dollars (\$15) per hour; and

WHEREAS, this increase shall not be used to amend or change any other salary or the ranges of salaries paid to any other member or members;

NOW, THEREFORE, in consideration of the mutual covenants and undertaking herein set forth the parties agree as follows:

1. The terms of the prior Memorandum of Agreement between the parties shall remain in full force and effect except as herein modified.

2. Wages:

Effective no later than 30 days from adoption by the Board of Chosen Freeholder, full time members employed by the County earning less than fifteen dollars (\$15) per hour shall be paid fifteen dollars (\$15) per hour.
