#### MEMORANDUM OF AGREEMENT

# TOWN OF MORRISTOWN AND UNITED SERVICE WORKERS UNION, IUJAT, LOCAL 255

THIS Agreement made this 22 day of vertex 2010 by and between the Town of Morristown (hereinafter the "Town") and the United Service Workers Union, IUJAT, Local 255, (hereinafter "Local 255").

WHEREAS, the Town and the Local 255 are parties to a Collective Bargaining Agreement ("CBA") that expired on December 31, 2008;

WHEREAS, the Town and the Local 255 have engaged in good faith negotiations to reach an agreement on terms and conditions for a successor CBA; and

WHEREAS, the parties have reached an agreement on terms for a successor CBA only subject to approval by the Mayor and Council, and ratification by the Local 255 membership; and

NOW, THEREFORE, in consideration of the mutual promises and undertakings herein set forth the parties agree as follows:

#### 1) ARTICLE 1- DURATION OF AGREEMENT

The term of the successor collective bargaining agreement shall be January 1, 2009 through December 31, 2011.

#### 2) ARTICLE 7- WAGES AND HOURS

Section A. Paragraph 1 of this Article shall be changed to the following:

Local 255 employees shall receive the following rate of pay increases during the term of this contract:

- > January 1, 2009 through December 31, 2009 0%
- > January 1, 2010 through December 31, 2010 0%
- > January 1, 2011 through December 31, 2011 2%

#### 3) ARTICLE 8- EMPLOYMENT DENEFITS

### Section A. Paragraph 1 of this Article shall be changed to the following:

The parties to this Agreement recognize the new State law Chapter 2, P L. 2010, effective May 21, 2010, regarding the implementation of a salary contribution for health insurance.

Effective May 29, 2010, the Town shall deduct the required minimum healthcare contribution from each employee in accordance with the provisions of Chapter 2, P.L. 2010. This shall replace any other healthcare contribution requirements in effect at the time of this Agreement, and shall not increase unless expressly mandated by law.

All other terms and conditions of the CBA that expired on December 31, 2008 not expressly amended herein shall remain in full force and effect.

## RESOLUTION AUTHORIZING THE EXECUTION OF A MEMORANDUM OF AGREEMENT BETWEEN THE TOWN OF MORRISTOWN AND THE UNITED SERVICE WORKERS UNION, IUJAI LOCAL 255

WHEREAS, the Town of Morristown (hereinafter the "Town") and the United Service Workers Union, IUJAI Local 255 (hereinafter the "United Service Workers") are parties to a Collective Bargaining Agreement ("CBA") that expired on December 31, 2008; and

**BE IT FURTHER RESOLVED,** that the Mayor and/or Business Administrator be and hereby is authorized to execute and the Municipal Clerk be and hereby is authorized to witness, the Memorandum of Agreement between the Town of Morristown and the United Service Workers, for the term beginning January 1, 2009 and ending December 31, 2011.
