MEMORANDUM OF UNDERSTANDING BETWEEN THE TOWN OF PHILLIPSBURG AND POLICEMEN'S BENEVOLENT ASSOCIATION LOCAL NO. 56

THIS MEMORANDUM OF UNDERSTANDING ("MOU") is made this <u>25</u> day of <u>June</u>, 2018 by and between the TOWN OF PHILLIPSBURG ("Town") and POLICEMEN'S BENEVOLENT ASSOCIATION LOCAL NO. 56, (Patrolmen) ("Association"), is established for the purposes and mutual understandings set forth below.

PBA 56 PROPOSALS - CLOSED ITEMS

- Article I. A. Include the word civilian.
 - Closed. The Town has agreed to insert the word "civilian" between the word "other" and "employees".
- Article II. Scheduled Duty Change- go from 24 to 72 hours.
 - Closed, no change.
- Article III. E. 20 days of full release time for Delegate.
 - Closed. We have agreed to eighteen (18) days of full release time for the Delegate.
- Article IV. A. Use of Bulletin Boards and secure Township email system.
 - Closed, no change.
- Article VII. A. Merge the grids.
 - Closed. Grids will merge (to the higher) and one (1) day will be added to the steps as well.
- Article VII. I. Omit in entirety.
 - Closed. We have agreed to reduce the time to five (5) days and will be deleting the second sentence.
- Article VII. K. Increase from one emergency day to two emergency days.
 - Closed. We agreed to increase the use of emergency vacation days from one (1) day to two (2) days.
- Article VIII. A. Holidays
 - Closed. Holidays determined by calendar year
- Article X. Conform the sick leave policy with that of vacation time policy for length of days. Closed. We have agreed to change B (2) to a day for day use of sick leave.
- Article XI Delete term permanent throughout Article. In-laws to be included in paragraph A Brother and sister in law to be included in paragraph B.
 - Closed. We have agreed to delete the term permanent throughout this Article. We have also agreed to include "in law" in paragraph A and "brother and sister in law" to be included in paragraph B of said Article.
- Article XIII Seniority accrues while officer is away on training or active duty. Paragraph C to be re-written.



Closed. We have agreed to acknowledge that seniority accrues while the Officer is away on training or active duty and we have agreed to delete paragraph C.

Article XIV Increase to \$1,000.

Closed. Increased to \$750.00.

Article XV Set new guide for overtime occasioned by 3rd party. Rate of pay to start at top step. Closed. We have agreed to set up new guide for overtime pay occasioned by off duty third party employment to be at the top step of pay.

Article XVI Set new minimum at 3 hours.

Closed, no change.

Article XVIII 2. Negotiate in good faith with the PBA.

Closed. The parties have agreed to negotiate in good faith.

G. Increase reimbursement for eye care to \$400.

Closed. The eye care has been increased for reimbursement from \$200 to \$300.

Article XVIII A. Change of insurance requires equal to or better than the existing plan. Closed, no change.

Article XVIII 3. Employee contributions return to pre Chapter 78 rates.

Closed, no change.

Article XX Salary increased to be negotiated through salary guide.

Closed. 2016-2018 1.85% across the board. 2019 and 2020, 2.0% across the board.K-9 stipend of \$5,000 per annum

Closed. We have agreed to a \$5,000 per annum K-9 stipend.

Det. and Special Ops stipend of \$5,000 per annum

Closed. Stipend of \$3,000.00 per annum. No double dipping (i.e., Det. who is also working Ops not entitled to stipend for both).

Article XXI Increase annual increment \$250 per guide. Include language that longevity shall be part of pensionable base salary.

Closed, no change.

Article XXIII Breakfast 10 Lunch 15 Dinner 25

Closed. We have agreed to increase meal reimbursement of \$10.00 for breakfast, \$15.00 for lunch and \$25.00 for dinner.

Article XXIV Step two filed with Public Safety Committee of Township Committee as a whole.

Closed. We have agreed to change the grievance language by replacing public safety committee with the Mayor.

Article XXXII Closed, no change.

***All changes covered in this agreement will be retroactive.

TERM OF AGREEMENT

The Agreement shall remain in effect until terminated by the parties.
