

MEMORANDUM OF AGREEMENT

Agreement made this 14 day of February, 2017 by and between the Township of South Brunswick (herein the Township) and PBA Local 166 (herein the PBA).

Whereas, the Township and the PBA are parties to a recently negotiated Collective Negotiation Agreement (herein CNA) covering the period January 1, 2015 to December 31, 2018; and

Whereas, the CNA has a newly negotiated term which provides for a one time stipend for officers covered by the contract who are Field Training Officers, Evidence Technicians and Drug Recognition Experts; and

Whereas, a question has been raised by the PBA in behalf of several of its members, some of whom are in the Bureaus where they are required to have one or more of the above listed certifications, concerning entitlement to this stipend; and

Whereas, it is the Township's position that only officers assigned to patrol who achieve one or more of the above listed certifications are eligible to receive the stipend; and

Whereas, the parties have determined to resolve the question by agreement to avoid the expense and uncertainty of outcome involved in use of the Grievance and Arbitration provision of the CNA:

Now, therefore in consideration of the mutual covenants and undertaking herein set forth, the parties agree as follows:


1. The following officers shall be paid the one time stipend of \$1,250.00;
 - a. PFC Frank Mongaleri
 - b. Patrolman Michael Lueng
 - c. Patrolman Jesse Blake
 - d. Detective Eric Tighelar
 - e. Detective Monica Shearer
 - f. Detective Nate Labuda
 - g. Sergeant Michael Pellino

2. The PBA recognizes and agrees that the stipend program is a patrol based program and that effective as of the date of this agreement only officers to patrol are eligible for the stipend.


3. The PBA further recognizes and agrees that patrol officers assigned to these tasks of FTO, ET and DRE must complete the required training and request the payment of the stipend by written memorandum to the Chief of Police.


