SIDEBAR AGREEMENT

The following is a negotiated Sidebar Agreement between the Township of Galloway (hereinafter, the Township) and the Government Workers Union-Police Communications Unit (hereinafter, the "Union") entered into on the 13h of norm, 2022.

WITNESSETH

WHEREAS, the Township is a public employer within the meaning of the New Jersey Employee-Employer Relations Act N.J.S.A 34:13A-1 et. Seq. (hereinafter, the "Act"); and

WHEREAS, the Union is an employee representative within the meaning of the Act who represents certain employees of the Township; and

WHEREAS, on or about May 30, 2019, the Township and the Union executed a Collective Bargaining Agreement ("CBA") for the period of time which covers January 1, 2019 to December 31, 2022; and

WHEREAS, Article Sixteen of the CBA addresses Holidays for the Union Members;

WHEREAS, at the time of negotiations of the CBA, the Township and the Union did not address compensation for Union members as it relates to June 19, the holiday designated as "Juneteenth":

WHEREAS, the Township and the Union wish to address compensation for Union members as it relates to Juneteenth through this Sidebar Agreement; and

NOW THEREFORE, in consideration of the mutual promises and representations herein contained, and intending to be legally bound, the parties understand and agree as follows:

1. The Township and the Union agree to amend portions of Article Sixteen of the CBA, to include Juneteenth to the list of recognized Holidays, and shall now read, in part:

"ARTICLE SIXTEEN-HOLIDAYS

A. "All full-time probationary and permanent employees shall receive the following holidays:

> New Year's Day Labor Day Martin Luther King Day Columbus Day Veteran's Day President's Day Thanksgiving Day Good Friday Day after Thanksgiving Memorial Day Juneteenth Christmas Day

4th of July

- C. Dispatchers will have the option to take time off for each of the thirteen (13) holidays regardless of the day they fall on. These holidays are based on an eight (8) hour day (104 holiday hours). Payment will be made in the first pay of November for all holiday hours not used during the year. The rate of pay will be straight time. Should an employee leave employment prior to the end of the year, only the unused hours for holidays that have passed will be payable."
- 2. The Township and the Union agree that the terms of this sidebar agreement do not set a precedent or past practice for other terms set forth in the CBA.
- 3. The Township and the Union agree that any compensation defined in this Sidebar Agreement will not be retroactive to the adoption of the contract, but will be effective as of June 1, 2022.
- 4. The Township and the Union acknowledge and agree that the other terms and conditions contained in the CBA applicable, including the other sections of Article Sixteen, remain in full force and effect.

SIDEBAR AGREEMENT

The following is a negotiated Sidebar Agreement between the Township of Galloway (hereinafter, the Township) and the Government Workers Union-Police Communications Unit (hereinafter, the "Union") entered into on the 16th of February 2022.

WITNESSETH

WHEREAS, the Township is a public employer within the meaning of the New Jersey Employee-Employer Relations Act N.J.S.A. 34:13A-1, et. seq. (hereinafter, the "Act"); and

WHEREAS, the Union is an employee representative within the meaning of the Act who represents certain employees of the Township, including employees in the Police Communications Unit; and

WHEREAS, on or about May 28, 2019, the Township and the Union executed a Collective Bargaining Agreement ("CBA") for the period of time which covers January 1, 2019 through December 31, 2022; and

WHEREAS, the CBA does not address additional compensation for the Assistant Communications Director, and

WHEREAS, the Union and Township wish to address additional compensation associated with shared service agreements for the Assistant Communications Supervisor, and

WHEREAS, this Sidebar Agreement will provide for extra compensation for the Assistant Communications Director for adding another municipality thru a shared service agreement totaling \$3,500 as a one-time addition to base pay.

NOW THEREFORE, in consideration of the mutual promises and representations herein contained, and intending to be legally bound, the parties understand and agree as follows:

1. The parties agree to amend the following article, to include additional compensation for the Assistant Communications Director, and shall now read:

"Article 38 Wages

E. Full-time communications operators shall receive a \$1,200 one-time addition to base salary for the first shared service agreement entered into by the Township (otherwise known as Mullica). If the Township enters into any additional shared service agreements, then each dispatcher would receive another adjustment to base for \$2,000, the Assistant Communications Director shall receive an additional \$3,500, and the Communications Director would receive a base wage adjustment of an additional \$5,000. Should a shared service agreement be terminated or not renewed, the addition to base salary will be removed."

- 2. Both the Union and the Township agree that this increase in compensation will begin once this sidebar agreement is executed and this will be effectuated prospectively and not retroactively.
- 3. Both the Township and the Union agree that the terms of this sidebar agreement do not set a precedent or past practice for other terms set forth in the CBA.
- 4. Both parties acknowledge and agree that the other terms and conditions contained in the CBA applicable remain in full force and effect.
