MEMORANDUM OF UNDERSTANDING BETWEEN

THE BOROUGH OF SADDLE RIVER AND LOCAL 108 PUBLIC SECTOR DIVISION, RWDSU, UFCW, AFL-CIO

THIS MEMORANDUM OF UNDERSTANDING, by and between the BOROUGH OF SADDLE RIVER (hereinafter referred to as the "Employer") and LOCAL 108 PUBLIC SECTOR DIVISION, RWDSU, UFCW, AFL-CIO (hereinafter referred to as "Union"), made and entered into on this _____day of December, 2020.

WHEREAS, the parties above have engaged in negotiations in good faith in an effort to arrive at a successor agreement to the Collective Bargaining Agreement between the Employer and the Union that will expire on December 31, 2020 (the "2018-2020 CBA"); and,

WHEREAS, the parties have arrived at a tentative successor agreement.

NOW, THEREFORE, and in consideration of the mutual covenants contained herein, the parties hereto stipulate and agree as follows:

- 1. The provisions of this Memorandum of Understanding are subject to ratification by the respective parties to the contract.
- 2. The signatories below agree to recommend this Memorandum of Understanding for ratification by their respective constituencies.
- 3. A copy of this Memorandum has been furnished to representatives of the Employer and the Union.
- 4. All proposals not covered herein made by either party during the course of negotiations have been deemed withdrawn.
- 5. All provisions of the 2018-2020 CBA shall be carried forward except as hereinafter provided.
- 6. Unless otherwise notified, all dates involving the duration of the Agreement shall be conformed to the duration of this proposed negotiated Memorandum of Understanding.
- 7. Duration: January 1, 2021 through December 31, 2024
- 8. <u>Wages (Article 22)</u>: A 2.25% annual increase to each employee's annual base salary for each year of the new contract.

- 9. Communications Officers Salaries (Article 24): Upon completion of the ninety (90) day Probationary Period, the annual base salary for Communications Officers shall be \$36,500. The annual base salary for Communications Officers shall be \$41,000 following two (2) years of employment.
- 10. <u>Senior Communications Officers (Article 24)</u>: Upon completion of two (2) years of employment as a Senior Communications Officer, the annual base salary of a Senior Communications Officer shall be \$45,500.

Upon completion of five (5) years of employment as a Senior Communications Officer, the annual base salary for a Senior Communications Officer shall be \$45,500.

11. <u>Operations Department/Public Work (Article 24)</u>: The following shall be the annual base salaries for the Operations Department/Public Works:

a.	Starting:	\$34,000 to \$37,000
b.	Upon completion of probationary period (90 days):	\$35,000 to \$38,000
		# 42 000
c.	Upon completion of first full year after probation:	\$43,000
d.	Upon completion of second full year after probation:	\$47,000
e.	Upon completion of third full year after probation:	\$51,000
f.	Upon completion of fourth full year after probation:	\$55,000
g.	Upon completion of fifth full year after probation:	\$61,000
h.	Upon completion of sixth full year after probation:	\$68,000
i.	Upon completion of seventh full year after probation:	\$71,000

- 12. Agency Fee: Section 4 of Article 2 shall be deleted in its entirety.
- 13. <u>Health and Welfare Benefit Contributions</u>: No change will be made to the amount of the employees' contributions to the cost of their medical insurance premiums set forth in Article 10 of the 2018-2020 CBA.

14. Salary Increase to Ms. Lipnick (Article 24): Ms. Lipnick shall receive a one-time increase of \$2,500.00 to her annual base salary as of January 1, 2021, however, she shall forego in 2021 the 2.25% per annum salary increase set forth in paragraph 8 hereof.
