AGREEMENT BETWEEN

THE MT. LAUREL BOARD OF EDUCATION

AND

THE MT. LAUREL ADMINISTRATORS

*Burlington County*

ARTICLE I

RECOGNITION AGREEMENT

The Mt. Laurel Board of Education hereby recognizes the Mt. Laurel Township Administrators' Association as the representative for professional negotiations concerning terms and conditions of employment for all Assistant Superintendents, Administrative Assistants, Principals, and Assistant Principals in the Mt. Laurel Township Public Schools within the scope of Chapter 303, P.L. 1968 (5746) known as the New Jersey Employer-Employee Relations Act, and as modified and interpreted by the Public Employees Relations Commission through its Rules and Regulations.

ARTICLE II

NEGOTIATION PROCEDURE

- A. The Mt. Laurel Board of Education agrees to negotiate terms and conditions of employment each year with the Mt. Laurel Township Administrators' Association.
- B. The Mt. Laurel Administrators' Association and the Board recognize that a majority of the Board and Administrators must ratify all agreements reached.

ARTICLE III

EDUCATIONAL MEETINGS

NATIONAL AND STATE AND LOCAL

Application to attend professional meetings will be made to the Superintendent. The Superintendent will review the request with the Board of Education for its approval. An amount of \$400.00 per administrator will be allotted for these meetings.

In addition to the above, one administrator may attend one national meeting with expenses fully paid, with Board approval.

ARTICLE IV

All twelve-month administrators will have twelve sick days each year.

ARTICLE V

Nothing in this agreement shall be interpreted and/or applied as to eliminate, reduce, nor otherwise detract from any ~~teacher~~ benefit existing prior to its effective date.

ARTICLE VI

Administrators be allowed to pay their professional dues through payroll deduction.

ARTICLE VII

SALARIES

ARTICLE VIII

DURATION OF AGREEMENT

- A. This Agreement shall be effective as of July 1, 1974, and shall continue in effect until June 30, 1975. This Agreement shall expire on the date indicated.
