CITY OF VENTNOR RESOLUTION NO. 133 OF 2018

A RESOLUTION OF THE CITY OF VENTNOR, COUNTY OF ATLANTIC, STATE OF NEW JESREY AUTHORIZING THE MAYOR TO EXECUTE AN AMENDMENT TO THE COMMUNICATIONS OPERATORS-TEAMSTERS LOCAL 929 CURRENT COLLECTIVE BARGAINING AGREEMENT

WHEREAS, The Mayor and City Commissioners have an agreement with the Communications Operators represented by the Teamsters Local Union No. 929; and

WHEREAS, the City of Ventnor and the Communications Operators represented by the Teamsters Local Union No. 929 wish to amend their current collective agreement as follows:

Article 12 Salaries (A). Delete existing language in contract attested to by City Clerk on March 14, 2018 and replace with the following:

If a dispatcher is designated as the Supervising Public Safety Telecommunicator, that dispatcher's base pay shall include an additional \$4,000 upon designation.

First opportunity to this designation shall be afforded to City Employees. Employees must meet all the requirements for said designation. The City has the right to limit current City Employees right to apply for opening based on discipline or attendance issues documented in the employees file.

Employee who is chosen for said designation will have a two (2) week trial period. Should employee wish to return to previous position, employee must submit a request to do so, in writing, to the Chief of Police within the trial period.

Provisional employee awaiting Civil Service permanent classification will receive the \$4,000 increase upon being assigned to the Supervising Public Safety Telecommunicator position. Should the employee fail to file, fail to meet job requirements, or not be chosen from a certified Civil Service (New Jersey Department of Personnel) list, this \$4,000 increase in salary will be forfeited from that point forward.

NOW, THEREFORE, BE IT RESOLVED that the Governing Body of the City of Ventnor formally approves this amendment to the Communications Operators Represented by the Teamsters Local Union No. 929 Collective bargaining agreement

BE IT FURTHER RESOLVED that the Mayor and Clerk are hereby authorized to sign the agreement on behalf of the City of Ventnor.
