ADDENDUM TO AGREEMENT
BETWEEN
BOROUGH OF MANASQUAN
MONMOUTH COUNTY, NEW JERSEY
AND
MANASQUAN P.B.A., LOCAL #284
JANUARY 1, 1991 THROUGH DECEMBER 31, 1992

THIS ADDENDUM shall supplement and amend an Agreement entitled "Agreement Between Borough of Manasquan, Monmouth County, New Jersey and Manasquan P.B.A. Local #284 - January 1, 1989 through December 31, 1990" (the "Prior Agreement") as follows:

1. All terms and conditions of the Prior Agreement shall apply for the employment term commencing January 1, 1991 and ending December 31, 1992 except as modified by this Addendum.

2. ARTICLE IX-SALARY, Section 1 is hereby modified to provide that the annual base salary for the classifications designated in this section for the pay period January 1, 1991 to December 31, 1991 shall be as follows and payable bi-weekly:

1991 salary shall equal the salary for the period 7/1/90 to 12/31/90 plus 6.5%.

Schedule "A" is attached to this Addendum setting forth the specific salary for each classification for the 1991 calendar year.

3. ARTICLE XVII-INSURANCE, HEALTH AND WELFARE, Section 4 is hereby amended to read as follows:

Immediately following the execution of this Addendum, the Employer shall make a diligent and good faith effort to enroll the Employee in a Prescription Drug Plan to provide that the Employee shall receive fully paid a \$2./\$4. full family prescription drug plan.

4. ARTICLE IX-SALARY, Section 1 is hereby modified to provide that the annual base salary for the classifications

designated in this section for the pay period January 1, 1992 to December 31, 1992 shall be as follows and payable bi-weekly:

1992 salary shall equal the salary for the period 1/1/91 to 12/31/91 plus 6.5%.

Schedule "A" is attached to this Addendum setting forth the specific salary for each classification for the 1992 calendar year.

5. Except as modified above, all terms and conditions of the Prior Agreement shall apply for the employment term commencing January 1, 1991 through December 31, 1992.
