Page 14 I. Teachers accompanying students on overnight trips shall be compensated at the additional rate of \$50.00 per night over and above their regular salary. Overnight is defined to mean a trip where pupils are housed away from home from one evening to the following morning.

- B. Health Care Insurance
 - For each eligible teacher the Board of Education will pay for Single coverage (Employee only), Program I under the New Jersey Dental Service Plan, Inc.
