MEMORANDUM OF AGREEMENT BETWEEN DEPTFORD TOWNSHIP AND TEAMSTERS LOCAL 676 PUBLIC WORKS/RECREATION

The following sets forth amended terms to which the above parties have agreed for the Collective Bargaining Agreement ("CBA") between Deptford Township and Public Works effective January 1, 2015 through December 31, 2017. Where there are no additions, deletions or revisions noted, the parties intend that the provisions of the current CBA shall remain unchanged and in full force and effect.

- 1. Deptford Township shall introduce a new Public Works' position titled "Working Foreman." Compensation for the Working Foreman position be set under the parameters of the Salary Ordinance.
- 2. Employees Tyler Wright and Jon Rapp shall receive an additional 2% annual salary increase for 2017 in addition to the 2017 annual salary increase designated for them and outlined in Exhibit "A" of the CBA.
- 3. Exhibit "A" of the CBA shall be revised to reflect employee Michael Beecher's change in title and salary from Laborer to Sign Maker I.
- 4. Exhibit "A" of the CBA shall be revised to add employee Jon Rapp as a Laborer with the appropriate Laborer's salary.
- 5. The two new Public Works union members, Stephen Seder and Joseph Watt, shall be added to Exhibit "A" of the CBA.
- 6. All employees highlighted in purple on Exhibit "A" of the CBA shall receive a 4% pay increase for 2016 instead of 2%.
