Addendum to Contract Dated November 2, 1973

THIS AGREEMENT, entered into this 1st day of March 1973 by and between;

THE BOROUGH OF NEW SHREWSBURY, a municipal corporation of the State of New Jersey, and

KERMIT BROWN, JR., THOMAS LEE BURCH, JOHN DEMEDICI, RUDOLPH G. GRASSO, JR., DAVID L. JORDAN, DONALD H. MUELLER, WILLIAM A. SEUFERT, LOUIS V. VITALE, La DEAN D. WHITE, WAYNE A. WHITE, FRED J. GARRABRANDT, GYETCHEL H. McCALL.

Whereas the parties have agreed that the Sergeants are properly a part of the "Unit" as previously defined in . . the Contract dated November 2, 1972, for consideration of the mutual promises herein they amend Paragraph I of said Contract to read;

The parties recognize the unit as being comprised of the above members of the Police Department of the Borough of New Shrewsbury, including Sergeants, Probationary Patrolmen and regular officers and excluding the Chief of Police or Lieutenants subject to the conditions outlined in Paragraph X below.

The parties hereby amend Paragraph III by deleting same from the Contract.

The parties hereby amend Paragraph VI to read:

The members of the Unit shall be paid at the annual salary rate for the period commencing July 1, 1972, through December 31, 1973, as follows:

| Sergeants | \$11,700.00 |
|------------------------|-------------|
| Patroln an First Class | 10,900.00 |
| Patrolman Second Class | 10,100.00 |
| Patrolman Third Class | 9,300.00 |
| Probationary Patrolman | 8,200.00 |

Parties hereby add Paragraph X to the Contract:

It is hereby expressly understood and agreed that if and when the Borough determines to establish the rank of Lieutenant in the department, the "Unit" shall not claim the right to bargain for or on behalf of said officers with respect to terms and conditions of employment, grievance procedure or other claims, provided further, that such officers are assigned management and supervisory duties as defined by the Public Employment Relations Act.

It is further understood and agreed between the parties that the retroactive pay which shall be come due to the sergeants under the adoption of this agreement shall be paid in a lump sum if funds become available in the 1973 budget, which shall constitute the difference between \$10,300.00 and \$11,700.00 prorated retroactively to July 1, 1972, less all sums paid to the sergeants above the rate of \$10,300.00 as a result of an increase granted

effective January 1, 1972 in the amount of \$567.00 being \$416.50 more or less.
