MEMORANDUM OF AGREEMENT

The Borough of Red Bank ("Borough") and PBA Local 39

("PBA") hereby agree to this Memorandum of Agreement to a

Collective Bargaining Agreement between the parties. Subsequent to the expiration of the most recent Collective Bargaining

Agreement on December 31, 2013, the parties have engaged in good faith negotiations regarding the terms of a successor agreement to cover the period of January 1, 2014 to December 31, 2017.

This Agreement is subject to ratification of the parties (the full membership of the PBA and the Red Bank Borough Council).

The parties agree to recommend ratification of this Agreement to their respective memberships (the Borough Council and PBA members, respectively).

- 1. <u>Term</u>. January 1, 2014 through December 31, 2017.

 Make the appropriate date changes throughout the Collective

 Bargaining Agreement.
- 2. Article VIII. 2% across the board increases per year on base salary, with all salary, step guide, and longevity increases paid retroactively from the date of the contract execution. The new salary guide is attached hereto as "Exhibit A".

- 3. ARTICLE VIII. There shall be a new salary guide for Officers hired on or after August 1, 2014. The salary guide for said employees is also attached hereto as "Exhibit A".
- 4. ARTICLE XXXIV. An increase of the "Payment in Lieu of Health Care" to be based on an individual's salary and health care premium, up to the maximum allowable by statute (\$5,000.00). For example, payment in the amount of \$3,750 shall be tendered to an Officer whose premium obligation is \$15,000 (25% of the premium up to \$5,000).
- 5. All prior contract provisions not directly altered by this Memorandum of Agreement shall remain in place in the successor Agreement.
 - 6. "Exhibit A" is subject to verification by both parties.
