AMENDMENT TO AGREEMENT

WHEREAS, there is in effect by and between the Board of Education of the Borough of Fairfield, Essex County, New Jersey, and the Fairfield Education Association an agreement which covers the period from July 1, 1971 through to and including June 30, 1973; and

WHEREAS, Article II of said agreement provides for the re-negotiation of salaries (not including fringe benefits) for the second year of said agreement under certain conditions therein defined; and

WHEREAS, the parties have renegotiated the issue of salary for the second year and are now in agreement concerning the same.

NOW, THEREFORE, it is hereby agreed by and between the parties hereto that the renegotiated Schedule A which is annexed hereto and made a part hereof shall be attached to the present agreement as an amendment thereto, and it shall go into effect beginning July 1, 1972 and terminating June 30, 1973.

NOTES

1. Teachers with prior public school service may be granted full credit for teaching experience up to 10 years.
2. Credit will be granted for 2 years military service with Honorable Discharge. Combined teaching and military service is not to exceed twelve years service.
3. Non-degree teachers shall advance one-half step yearly on the guide.
4. Annual increments for satisfactory service shall be granted by the Board of Education upon recommendation of the Chief School Administrator. The Board of Education reserves the right upon recommendation of the Chief School Administrator to withhold, decrease or reinstate any annual increment or adjustment. (18A: 29-14)
