RESOLUTION OF THE BOROUGH OF FORT LEE AUTHORIZING THE EXECUTION OF MEMORANDUM OF AGREEMENT CONCERNING HOLIDAY OBSERVANCE FOR COMMUNICATIONS CENTER EMPLOYEES ONLY

WHEREAS, the Borough of Fort Lee ("Borough") is a municipal corporation of the State of New Jersey in the County of Bergen, established in accordance with N.J.S.A. 40A:60-1 et seq.; and

WHEREAS, the United Service Worker's of America ("Union") is a union labor organization on behalf of certain blue collar employees of the Borough; and


WHEREAS, the Borough and the Union entered into a Collective Negotiations Agreement ("CNA") for blue collar employees, which term was effective from January 1, 2017 to December 31, 2020 and which was subsequently extended until December 31, 2022; and

WHEREAS, the Borough and the Union have discussed and agreed upon a Memorandum of Agreement modifying the CNA's terms relating to the observance of holidays for the Police Department's Communications Center employees only; and

WHEREAS, the terms and conditions of the Memorandum of Agreement have been examined and approved by the Borough Attorney and is attached hereto.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Fort Lee that the Mayor and Borough Clerk hereby approves and authorizes the execution of the Memorandum of Agreement between the Borough and the Union as approved by the Borough Attorney.

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately.
