WHEREAS pursuant to Article XVIII, paragraph A., 2.1, the negotiating teams representing the respective parties hereto did agree to a tentative Fort Lee Teachers' Salary -Guide Schedule for the school year July 1, 1983 through June 30, 1984, subject, however, to a formal written agreement to be approved and executed by and between the parties hereto,

NOW, THEREFORE, IT IS AGREED between the Board and the Association as follows:

1. The salary schedule for the school year, July 1, 1983 through June 30, 1984, as set forth on Exhibit C-1, which is attached hereto and made part hereof, be and the same is hereby approved, ratified and confirmed.
