ADDENDUM AGREEMENT

between

COUNTY OF PASSAIC. A PUBLIC EMPLOYER,  
(hereinafter referred to as the "County")

and

PASSAIC COUNTY CLERICAL EMPLOYEES ASSIGNED TO THE  
OFFICES OF THE REGISTER, SURROGATE, JUVENILE AND  
DOMESTIC RELATIONS COURT, DISTRICT COURT, PROBATION  
and COUNTY CLERK, REPRESENTED BY THE PASSAIC COUNCIL  
#3, NEW JERSEY CIVIL SERVICE ASSOCIATION, INC.,  
(hereinafter referred to as the "Council")

W I T N E S S E T H:

WHEREAS, the County of Passaic does recognize the Passaic Council #3, New Jersey Civil Service Association as the exclusive representative for the purpose of collective negotiations with respect to wages, hours of work and other terms and conditions of employment for all clerical employees assigned to the offices of the Register, Surrogate, Juvenile and Domestic Relations Court, District Court, Probation and County Clerk of the County of Passaic, exclusive of those whose duties are administrative and supervisory within the meaning of the "Act",

NOW, THEREFORE, be it resolved that the County and the Council mutually agree that the following shall represent the Agreement reached as the result of collective negotiations for the contract years beginning January 1, 1979 through December 31, 1980.

COMPENSATION

For Year 1979:

- b) All employees to receive a six (6%) percent adjustment in their base pay effective July 1, 1979.

For Year 1980:

- a) Effective January 1, 1980, the base pay of all employees to be adjusted by four and one-half (4½%) percent.
- b) Effective July 1, 1980, the base pay of all employees to be adjusted by an additional four and one-half (4½%) percent.
- c) Increment when due the employee in accordance with County policy.


All other Articles contained in the existing Agreement not modified herein shall remain in full force and effect for the contract years of 1979 and 1980.




