AGREEMENT made and dated this 26th day of April 1977 by and between the City of Paterson, Department of Public Works and Passaic Council No. 3, Supervisors Chapter, N.J.C.S.A.

WHEREAS, the parties wish to modify the present AGREEMENT in accordance with negotiations which commenced on March 8, 1977 under a "reopener" with respect to parity and weekend work, and

WHEREAS, the parties wish to extend the term of the present contract to December 31, 1978;

NOW THEREFORE, it is mutually agreed as follows:

1. The employees in the bargaining unit who work weekends on a rotational basis, shall effective 1977 receive an additional two (2) days leave per year which shall be added to their vacation.
 - a. The employees shall sign "in" and sign "out" on the weekend days worked in a "log book" provided for this purpose.
 - b. The employees shall indicate in the "log book" the duties they performed while on weekend duty.
2. The following employees shall reach parity in two steps as indicated below:
 - a. John Audino shall be compared with the Supervisor of Streets and Roads.
 - b. Robert Angelica, James Liguori, Anthony Daunno, Robert Schaublin and Dominick Gerone shall be compared with the Foreman of Laborers.
 - c. One half of the amount necessary to reach parity shall be added to the employee's base salary on the first complete payroll in July 1977 and one half on the first complete payroll in July 1978.
 - d. To determine the amount necessary to obtain parity, the parties agree to use the length of time in the title of the positions being compared.
 - e. The following includes the names of the employees involved, the amounts to be added to their base salary and the dates said monies are to be added:
