SCHEDULE "C"

HOSPITALIZATION

Basic Plan Blue Cross and Blue Shield (Rider J) as well as Major Medical. The Board shall pay premium for:

1. Full single coverage for single employee.
2. The Board shall pay 70% of the full family plan premium for each teacher.

ARTICLE 28

DURATION OF AGREEMENT

28:1 It is agreed between the parties that this contract shall be effective for the period July 1, 1974, through June 30, 1976 with the exception of the articles in this addendum. This Agreement shall not be extended orally, and it is expressly understood that it shall expire on the date indicated, unless it is extended in writing.

28:2 In witness whereof the Association has caused this Agreement to be signed by its President and Secretary and the Board has caused this Agreement to be signed by its President, attested by its Secretary and its corporate seal to be placed hereon, all on the day and year first above written.
