



## **MEMORANDUM OF AGREEMENT**

Agreement made this <u>27, 4</u> day of September 2019 by and between the County of Union (herein the Employer") and PBA 203, Union County Division of Weights and Measures (herein the "Union"):

WHEREAS, the Employer and the Union are parties to a Collective Negotiations Agreement (herein "CNA") covering the period from January 1, 2015 to December 31, 2017; and

WHEREAS, the Employer and the Union have engaged in good faith negotiations for a successor contract that has resulted in an agreement between the negotiating committees subject to ratification by the Union membership and approval by the Employer's governing body:

NOW, THEREFORE, in consideration of the mutual covenants and undertakings herein set forth the parties agree as follows:

- 1. Except as herein modified, the terms and conditions of the 2015-2017 CNA shall remain in full force and effect.

#### 5. <u>ARTICLE 23, DURATION</u>

January 1, 2018 through December 31, 2020.
