ARTICLE IX

Faculty Salaries and Deductions

9.3 The salary schedule and overload rate for ten-month employees for the academic year 1976-1977 are incorporated as Appendix A. Each present faculty member shall receive the increment appropriate to current rank plus \$750.00 above present salary in accordance with Memorandum of Agreement executed by the parties on May 3, 1976.

ARTICLE XV

Duration of Agreement

15.2 This Agreement shall be effective for a period of three (3) years starting July 1, 1974 through June 30, 1977, subject to the following:

By January 1, 1977, either party may notify the other in writing of its desire to reopen the Agreement for negotiations for a subsequent Agreement.
