AGREEMENT made this 1st day of October, 1978 between SCOTCH PLAINS-FANNOCD BOARD OF EDUCATION, hereinafter referred to as "Board" and LOCAL 102, AN AFFILIATE OF THE INTERNATIONAL BROTHERHOOD OF TEAMSTERS, CHAUFFEURS, WAREHOUSEMEN AND HELPERS OF AMERICA, hereinafter known and designated as the "Union."

### ARPICLE I - RECOGNITION

• • • • • •

The Board recognizes the Union as the exclusive collective bargaining representative for the head custodians and assistant custodians, maintenance personnel, grounds personnel and bus drivers, it being agreed that this unit excludes office, clerical, administrators and supervisors. It is acknowledged by the parties that the head custodians, assistant custodians, maintenance personnel, grounds personnel, and bus drivers are employed on a 12-month contract unless altered by individual contract

## ARTICLE II - CHECK OFF

- (1) The Board agrees to deduct from the salaries of the members of the unit the dues for the Union and the Pension Fund. Such deduction shall be made in compliance with NJSA 52:14-15.9 and under the rules established by the State Department of Education. Said Union dues moneys, together with the record of any corrections, shall be submitted to the Treasurer of the Union by the 15th of each month following the monthly pay period during which deductions were made. A form of authorization for the deduction of such moneys shall be executed by each member of the unit. In the event the Union shall change the amount of dues, it shall give the Board written notice prior to the effective day of such change.
- (2) All new employees may from and after the 31st day following the date of their employment apply for membership in the Union in accordance with the provisions of Chapter 123, Laws of 1974. Nothing herein shall be construed as making Union membership a condition of employment, nor shall any individual be compelled to

join the Union at any time. However, in accordance with the provisions of Chapter 123, Laws of 1974, and as heretofore set forth in this Agreement, the Union shall be recognized as the exclusive collective bargaining representative for the members of the unit described.

## ARTICLE III - MANAGEMENT

The Board may not, by agreement or through arbitration, delegate powers and responsibilities which by law are imposed upon and lodged with the Board. Any contramust include and therefore be subject to the New Jersey school laws and all other applicable laws and regulations.

The Board, on its own behalf and on behalf of the electors of the district, hereby retains and reserves unto itself, without limitation, all powers, rights, authority, duties and responsibilities conferred upon and vested in it by the laws and Constitution of the State of New Jersey, and of the United States, including, but without limiting the generality of the foregoing, the right:

- (1) to the executive management and administrative control of the school system and its properties and facilities, and the activities of its employees;
- (2) to hire all employees and subject to the provisions of law, to determine their qualifications, and the conditions for their continued employment, or their dismissal or demotion; and to promote, and transfer all such employees;
- (3) to determine the shift schedules, special duties, school assignment and specific scheduling of duties of each of the employees within the unit.

The exercise of the foregoing powers, right, authority, duties and responsibilities in the Board, the adoption of policies, rules, regulations and practices in furtherance thereof, and the use of judgement and discretion in connection therewith shall be limited only by the specific and express terms of this Agreement and then only to the extent such specific and express terms thereof are in conformance with the Constitution and laws of the State of New Jersey, and the Constitution and laws of the United State

Nothing contained herein shall be considered to deny or restrict the Board of its rights, responsibilities and authority under the New Jersey school laws or any othe national, state, county, district or local laws or regulations as they pertain to education.

The parties further acknowledge that this Agreement has been negotiated and executed with the objective of setting forth mutual rights, obligations and responsibilities. The parties further agree that in all aspects of their relationships they shall comp with all appropriate law and recognized standards of professional conduct and professional relationships. There shall be no discrimination by the Board against any officer of the Union for any legal activity in carrying out his office, nor shall the Union or any of its members encourage or conduct a strike, impose sanctions or undertake any concerted activity which shall cause a slow-down or disruption of any of the operations and activities of the school system. Any grievance arising under and out of this Agreement shall be prosecuted within the framework of the Grievance Procedure. The Board acknowledges that it shall fully comply with all of the obligations and responsibilities imposed upon it by this Agreement and shall take no action nor conduct any activities which shall impair the operation of this Agreement.

# ARTICLE IV - HOURS OF WORK AND OVERTIME

- (1) A working day shall consist of the period between 12:01 a.m. to 12:00 midnight.

  A working shift shall consist of eight working hours in the period of eight and one half continuous hours. The breakdown of this shift shall be as follows:
  - (a) One and one-half hours after the beginning of the shift a fifteen minute period will be allowed for a coffee break.
  - (b) Three hours and forty-five minutes after the beginning of the shift a fifteen minute period will be allowed for pickup of tools and cleanup.

- (c) Four hours after the beginning of the shift a one half hour period will be allowed for lunch.
- (d) Eight hours and fifteen minutes after the starting time of the shift a fifteen minute period will be allowed for pickup of tools and cleanup.
- (e) Eight and one half hours after the beginning of the shift the working day will terminate.
- (f) The schedule for working shifts in a working day will be established by the Board.
- (2) A working week shall begin at 12:01 a.m. Monday and shall continue through 12:00 midnight Sunday.
- (3) A normal working week will consist of one working shift on each day from 12:01 Saturday to 12:00 midnight Friday.
- (4) For night work, which for the purposes of this provision shall be deemed to be work actually performed within the shift commencing 3:00 p.m. and extending until:30 p.m., a premium of 6% shall be paid constituting payment for shift differential effective July 1, 1978. For all night work, which for the purpose this provision shall be deemed to be work actually performed within the shift commencing 11:00 p.m. and extending until 7:30 g.m., a premium of 10% shall be paid which shall constitute payment for shift differential. The premium pay for each shift shall be computed based upon the basic hourly rate and for actual work performed.
- (5) During the summer menths the day shift shall commence work at 7:00 a.m. and one-half hour shall be provided for lunch. All night custodians shall work the aforesaid day shift during the summer months. The summer months shall commence on July 1 and terminate on August 30.
- (6) Whenever schools are closed for one full week or more, employees shall perform their work during the first shift whenever possible without any effect on

their normal rate of pay, including differential, unless the employee is needed at other times due to particular work or activities. The wages to be paid to members of the unit are set forth on the Schedule of Wages which is annexed he and made a part hereof as Appendix A-1.

Overtime. The hourly rate for overtime for the head custodians and assistant custodians and assistant custodians and assistant custodians are personnel, grounds personnel and bus drivers shall be established by dividing 2080 hours into the yearly salary of such employee. Overtime, if authorize by the administration shall be paid at the rate of time and one-half as follows:

- (a) All work performed in excess of eight hours in any one work day or in excess of forty hours in any one work week shall be compensated at the rate of one and one-half times the hourly rate.
- (b) All work performed on the sixth (6th) consecutive day worked in the work week. Whenever an employee is absent on any of the first five (5) days of that employ scheduled work week, and works on the sixth (6th) day of such work week, time a one-half shall be paid such employee for all hours worked on the sixth day, provided that the employee has been excused by his or her supervisor or his or her supervisor is satisfied that his or her absence was justified. Work perform a Sunday shall be paid for at the rate of double time, provided Sunday is the seventh (7th) consecutive day worked in the week, except as indicated below in paragraph (d).
- (c) In the event an employee is required to work on a recognized holiday, he or she will receive, in addition to his normal compensation for that day, one and one timeshis or her hourly rate of pay as is computed in this Article for work per on the holiday.
- (d) In the event that a head custodian is required to conduct building checks on either Saturday, Sunday or holidays, it is agreed that they should be paid at the rate of 1½ times their normal daily rate for the actual time during whi

they conducted the examination. At other times, or when replacing a head custodian on building checks, an employee shall be granted a minimum of 2 hour pay when called out to perform emergency work outside of the employee's regula shift.

Overtime Limitations. A tour of duty including overtime shall not exceed a total of sixteen continuous hours. A lunch period of one-half hour will be allowed after eafour working hours.

Any employee authorized to continue a particular job after the end of his or her shi will be paid one and one-half times his or her hourly rate for the actual time spen-beyond his or her normal shift, plus fifteen minutes allowed for clean-up.

The Board reserves the right to deduct time lost from the wages of those employees who shall make a custom or practice of reporting late for their assigned shift.

Overtime days, when authorized and required by the Board, shall be performed. The assignment of overtime will be upon a rotating basis based on seniority. The Board reserves the right to remove from the overtime list any employee not reporting for such overtime duty when required.

#### ARTICLE V - SENIORITY

It is the established policy of the Board that employees within the unit shall not eligible for tenure until the expiration of three consecutive years of employment with the Board. However, the Board agrees to recognize, in advance of that date, seniority for the purposes of (a) vacation scheduling, and (b) layoff of employees, provided that the employee shall have the necessary qualifications, skill and abilito perform the work which may be available. In addition, the Board agrees that the shop steward shall during his term of office have top seniority for the purposes of

layoff and recall, provided he has the qualifications, skill and ability to perform the work available.

Employees shall lose all seniority rights for the following reasons:

- (a) Voluntary resignation.
- (b) Discharge for just cause.
- (c) Failure to return to work within five working days after being recalled from layoff and being notified by certified mail, unless failure is due to actual illness or accident.
- (d) Five days of unexcused absence.
- (e) Breach or violation of any condition set forth in this Agreement.

#### ARTICIE VI - HOLIDAYS

The Board will establish and grant to the head custodians and assistant custodians, maintenance personnel, grounds personnel and bus drivers thirteen (13) holidays per year. (See schedule of holidays annexed hereto as Appendix B.) In the event the holiday shall fall on a Saturday or Sunday, it shall be celebrated on a day selecte at the discretion of the employer. In the event a holiday falls during an employee vacation period, such employee shall receive an additional day's vacation. In orde to receive holiday pay, an employee must work the regular scheduled work day before the holiday and the regular scheduled work day after the holiday, unless he or she has been excused by his or her supervisor or unless the administration is satisfied that his or her absence was justified.

# ARTICLE VIA - VACATIONS

All employees covered by the terms of this Agreement shall receive vacations with at the regular rate according to the following schedule:

(a) Employees will receive vacations in accordance with the following schedule:

Years Completed Service	Vacation Days
1-4	10
5–9	15
10-19	20
20 or more	25

- (b) Any employee entering into an employment agreement prior to January 1 will receive 10 working days of vacation in the following contract year;
- (c) Any employee entering into an employment contract between January 1 and June 30 will receive one day of paid vacation for each month of service in the following contract year.

Vacation time earned in any one contract year must be used in the following contract year and vacations shall be noncomplative. The Board also reserves the right to establish a uniform district-wide vacation period, and will afford the employees reasonable notice of such uniform vacation period. In the absence of a district-wide vacation period, all employees shall submit between January 1 and January 15, on a form to be approved, their request for vacation during the period July 1 through August 31. Such requests shall be acted upon on or before February 1. An employee may also apply for a vacation outside of the June 1 through August 31 period, which request shall require specific approval.

# ARPICIE VII - BOILER'S LICENSE

The Board agrees to pay the school cost for the obtaining of a boiler's license. The Board further agree to pay the fee to obtain the license and shall also pay the fee for license renewal of all employees approved to hold such a license.

## ARTICLE VIII - SICK LEAVE

Head custodians, assistant custodians, maintenance personnel, grounds personnel and bus drivers shall receive 12 days paid sick leave per year after one year of service shall receive one day of sick leave purposes with less than one year of service shall receive one day of sick leave purposes with for each month actually worked. In accordance with the New Jersey statutes, sick leave may be cumulative but not be applicable to early retirement nor shall there be any payment for sick leave days accumulated. The Board reserves the right to require the production of a doctor's certificate in appropriate cases.

## ARTICLE IX - PENSION PLAN

The existing pension plan, as is made and provided for in accordance with the New J statutes, shall be continued.

# ARTICIE X - MILITARY SERVICE

Members of the dryanized Reserve of the United States Naval Reserve, United States Reserve, United States Air Force Reserve or United States Marine Corps Reserve shabe entitled to leave of absence without loss of pay on all days in which they shall be engaged in actual field training. A military leave without pay shall be grants to any employee having tenure entering the military service of the United States. Such employee shall be entitled to the benefits, rights and privileges with respect to tenure and pension and the benefits which he or she would have had or acquired leave of absence in accordance with the New Jersey statutes.

#### ARTICLE XI - HOSPITALIZATION: MEDICAL AND DENTAL INSURANCE

- (1) The Board shall provide for and pay the cost of a health insurance program.

  Major medical and hospital life insurance company, or any other carrier so a

  benefits are equal to or greater than Blue Cross, Blue Shield or Rider J.
- (2) The Board agrees to provide a basic dental plan. The plan shall be New Jers Dental Service Plan, family coverage, \$25.00 deductible per individual, and

- \$75.00 per family. Children are covered to the age of 23 unless married.
- (3) The Board shall provide for Health Care Insurance for individuals within the unit who retire within the contract period, after serving the Scotch Plains-F. School District for 20 years or more. The coverage provided shall be that uncourrent contract less Medicare when the individual is eligible for Medicare. The cost of retirement coverage shall be as follows:

## ARTICLE XII - TEMPORARY LEAVES OF ABSENCE

During the term of this Agreement employees shall be entitled to the following temple leaves of absence without loss of pay, which leave shall be non-cumulative except as hereinafter stated:

(1) A total of two days leave of absence for such personal or other matters which require absence during working hours. Employees shall be permitted to accumulate one unused day in any year so that a maximum of three personal days may be utilized in any one year. Application to the employee's immediate superior f such leave of absence shall be made at least five days before taking such leave (except in the case of emergency), and the applicant shall not be required to state the reason for taking such leave.

- (2) The actual time necessary for appearance in court or before a state administrative agency pursuant to a duly issued subpoena. The subpoena shall be presented to the building principal or immediate superior in advance of the appearance at court or the administrative agency for approval.
- (2) A maximum of five days at any one time in the event of the death of a mother, father, spouse or child. A maximum of three days in the event of the death of a brother, sister, father-in-law, mother-in-law, brother-in-law, sister-in-law grandfather or grandmother.

## ARTICLE XIII - UNIFORMS

The Board will furnish to each employee three uniforms, to consist of three pairs of pants and three shirts, within the contract period, and the Board will further assume the cost of cleaning such uniforms. Uniforms will be furnished on a loan basis and returned to the Board at the end of the contract year. The Board will also furnish at no cost to the employee one pair of steel toe safety shoes each year. Other items of clothing and safety equipment, such as rain gear, boots, coveralls, safety goggles and respirators, will be furnished as required by the Department of Labor and Industry or deemed recessary by the administration.

# ARTICLE XIV - POSTING OF JOBS

Job vacancies shall be posted on the bulletin board. However, the Board reserves to right to determine the experience and qualification of each member of the unit to fill the vacant post. All internal candidates will be granted interviews for vacancies for which they formally apply.

# ARTICLE XV - RIGHTS OF VISITATION

The business agent or his representative or any officer of the Union shall be perm to transact official Union business on school property at all reasonable times, provided that it shall not interfere with nor interrupt normal school operations a comply with the Board of Education policy on visitation to the schools. Such representatives shall first notify and obtain the permission of the building principor or his designee to enter the building. Such permission shall not be unreasonably withheld. It is further understood that this privilege shall be exercised so as to keep at a minimum the time lost thereby to the Board.

#### ARTICLE XVI - BULLETIN BOARD

The Union shall have in each school building space on a bulletin board in proximity to the custodians' area, which may be used for the purpose of posting Union notices relating to meetings, dues, entertainment, health and safety and general Union activities. Copies of all materials which will be posted on the bulletin board will be given to the building principal.

## ARTICLE XVII - TENURE

Employees without termine shall be offered a contract prior to the expiration of each school year. The Board may grant tenure to any employee after three calendar years of continuous service by offering a contract to the employee at the end of three consecutive years of employment. Prior to that time the Board reserves the right to discharge any employee or to refuse to offer a contract to any employee at the end of the school year. The Board will, however, agree to furnish the employee and the Un with the reasons for either his or her discharge or nonrenewal of contract. Such discharge or nonrenewal shall not be grievable within the framework of this Agreeme

# ARTICIE XVIII - TRANSFERS

The Board reserves the right to transfer employees so as to best serve the needs of school district. However, the Board agrees that if an employee is temporarily transferred to a lower rated job, he or she shall be paid his or her regular rate of pay. In addition, the Board further agrees that if an employee works twenty hours more in the course of any one work week in a higher job classification, he or she

shall receive the rate of pay of the higher classification for all hours actually worked in that classification during the particular week.

## ARTICLE XIX - MAINTENANCE OF EXISTING CONDITIONS

The Board hereby agrees to maintain existing conditions as they affect the terms are conditions of employment provided that such existing conditions shall not be contrate to nor abridge and modify the provisions as are set forth in this Agreement.

### ARTICLE XX - GRIEVANCE PROCEDURE

A "grievance" shall mean a complaint by an employee or group of employees that there has been to him or her or to them or to the Union an inequitable, improper or unjust application, interpretation or violation of Board policy, State law or this Agreement that the term "grievance" shall not apply to (a) any matter for which a specimethod or review is prescribed and expressly set forth by law or any rule or regular of the State Commissioner of Education, or (b) a complaint of a nontenure employee which may arise by reason of his discharge or nonreemployment.

# Procedure:

- (1) A grievance to be considered under this procedure must be initiated within thirty calendar days of its occurence.
- (2) Failure at any step of this procedure to communicate the decision on a grievan within the specified time limits shall permit the "aggrieved" to proceed to the next step. Failure of the "aggrieved" at any step of this procedure to appeal a grievance to the next step within the specified time limits shall be deemed be acceptance of the decision rendered at that step.
- (3) Since it is important that grievances be processed as rapidly as possible, the number of days indicated at each level should be considered as a maximum :

- every effort should be made to expedite the process. The time limits specifinary, however, be extended by mutual agreement.
- (4) In the event a grievance is filed at such time that it cannot be processed to all the steps in this grievance procedure by the end of the contract year, to limits set forth herein shall be reduced so far as practicable so that the procedure may be exhausted prior to the end of the contract year.
- (5) It is understood that employees, shall, during and notwithstanding the pends of any grievance, continue to observe all assignments and applicable rules a regulations of the Board and administration until such grievance and any eff thereof shall have been fully determined.
- (6) <u>Level Cne</u> An employee with a grievance shall first discuss it with the heat custodian, foreman or immediate supervisor in an attempt to resolve the matter informally at that level.
- (7) <u>Level Two</u> If as a result of the discussion, the aggrieved person is not sawith the disposition of his or her grievance at Level Cne, he or she may for file the grievance in writing with the Union within five days after the deciat Level Cne or ten days after the grievance was presented, whichever is so Should the Union deem the grievance to be a valid and meritorious one within days after receiving the written grievance, the Union shall refer the grievance the immediate supervisor in writing, specifying: (a) the nature of the grie (b) the nature and extent of the injury, loss or inconvenience; (c) the rethe previous discussions, and (d) the aggrieved employee's dissatisfaction the decision previously rendered. The immediate supervisor shall meet with aggrieved and the Union prior to communicating his written decision.
- (8) <u>Level Three</u> If the aggrieved person is not satisfied with the disposition has been rendered with five days after the grievance was delivered to the immediate supervisor by

Union, or three days after the meeting between the immediate supervisor, the aggrieved and the Union, whichever is later, he or she may within five days after the decision by the immediate supervisor or fifteen days after the grievance we delivered by the Union, whichever is sooner, request in writing that the Union refer the grievance to the Assistant Superintendent for Business or his designs

- (9) Level Four If the aggrieved person is not satisfied with the disposition of his or her grievance at Level Three or if no decision has been rendered within days after the grievance was delivered to the Assistant Superintendent for Business or she may within five days after a decision by the Assistant Superintendent Business or fifteen days after the grievance was delivered to the Assistant Superintendent for Business, whichever is somer, request in writing that the Superintendent his or her grievance to the Superintendent of Schools.
- or her grievance at Level Four, or if no decision has been rendered within ten after the grievance was delivered to the Superintendent, he or she may within for days after a decision by the Superintendent or fifteen days after the grievance was delivered to the Superintendent or fifteen days after the grievance was delivered to the Superintendent, whichever is sooner, request in writing to the Union submit his or her grievance to the Board of Education or to a commit designated by the Board. The grievance shall set forth the elements contained Level Two, together with all prior decisions. The Board may hold a hearing with affected employee, or in its discretion may render a decision based upon the record submitted.
- (11) Level Six In the event an employee is dissatisfied with the determination of Board, he or she may request the Union to submit a formal demand for advisory arbitration pursuant to the rules and regulations established by the Public Employment Relations Commission under the provisions of Chapter 303, Laws of A request for such advisory arbitration shall be made no later than fifteen d following the determination of the Board. Failure to file within the said ti

shall constitute a bar to such arbitration unless the parties have extended the time by mutual agreement. Within ten (10 days after receipt of the written no of demand for advisory arbitration, the Association and the Board shall make a joint request to the American Arbitration Association for a list of arbitrator. from which one will be selected by the parties. In the event the parties are : able within three days after the receipt of the list to select an arbitrator, second list shall be requested. If the parties are unable to agree upon a nut satisfactory arbitrator from the second list within five days after receipt the the American Arbitration Assocation may select an arbitrator from the list, which arbitrator shall them serve. The arbitrator shall be empowered to hold. hearing or hearings and to obtain all relevant data concerning the grievance. He shall render a written submission of any additional data. A copy shall be simultaneously furnished to the Association and the Board. The arbitrator shall limit himself to the issue submitted and shall consider nothing else. He can add nothing to nor subtract anything from this Agreement between the parties of any policy of the Board of Education. The recommendations of the arbitrator si be advisory. The cost of the arbitration proceeding shall be home equally by the carties.

(12) Miscellaneous - It is understood that the employee shall deliver and, notwithst the pendency of any grievance, continue to observe all assignments and applicate rules and regulations of the Board and administration. It is further understoot and agreed that all proceedings under this Procedure shall be conducted after hours. However, in the event that any party in interest requires time during school day for the obtaining of documents or other materials pertaining to the hearing, he or she shall apply to the Assistant Superintendent for Business the his or her immediate supervisor to obtain released time. Should the Assistant Superintendent for Business or his designee determine that there is no other alternative, he may approve released time.

## ARTICLE XXI - TERM OF THE AGREEMENT

This Agreement shall be effective July 1, 1978 and shall continue and remain in ful force and effect to and including June 30, 1980, when it shall expire.

## ARTICLE XXII - ENTIRE AGREEMENT

This Agreement and its appendices shall constitute the entire Agreement between the parties and shall not be modified in whole or in part by the parties except by an instrument in writing duly executed by both parties. This Agreement shall supersed existing Board policies, rules and regulations where any conflict arises.

#### ARTICLE XXIII - MISCELLANECUS

The Board agrees that, except in cases of emergencies, outside contractors will be employed to clean the boilers in the schools.

### ARTICLE XXIV - NOTICE PROVISIONS.

Whenever any notice is required to be given by either of the parties to this Agreement to the other, pursuant to the provisions of this Agreement, either party shall do so talegram or by certified mail at the following addresses:
