ADDENDUM

ARTICLE VIII

- (6) Terminal leave: Any employee having been in the employ of the school district for twenty (20) or more years, who submits to the Superintendent a written statement of intention to retire, shall be eligible for a special retirement allowance, provided notice of such intention to retire is given to the Superintendent at least two (2) months before the final budget submission date for the budget involving the year of retirement. That retirement allowance shall be computed at the rate of one day's pay for each six (6) days of accumulated unused sick leave to the employee's credit at the time of the announced contemplated retirement. That daily compensation to the employee under the aforesaid provisions shall be at the daily rate of pay which they earn in their last year in the District.

ARTICLE IX

- (4) Dental Insurance:
The Board shall provide a full dental plan for each employee for the 1983-1984 school year.
