Memorandum of Understanding Between P.B.A. Local 130 The Borough of Princeton

We the undersigned agree to the following contractual items for the period of January 1, 2010 through December 31, 2012.

Salary:

- 1.5% Salary increase 2010
- 2.4% Salary increase 2011
- 2.4% Salary increase 2012

Tuition Reimbursement

A \$500 increase in College Tuition for 2010 Contingent upon modifying the acceptable reimbursement to achieving a grade of B or better

Additional:

Eliminate vision reimbursement for all members hired after 1-1-2011.

Section 1.03 Employees represented by this collective bargaining unit may not request payroll deduction for payment of dues to any other labor organization other than the duly certified majority representative. Existing written authorizations for nonpayment of dues to any other labor organization shall be terminated

Section 5.02F Stand By, Call Back, Training Time and Firearems Qualifications

All patrol officers assigned to the 12 hour shift who are required to be on standby, shall be granted 36 hours of compensatory time on an annual basis as reimbursement for standby. The compensatory time shall be granted on January 1st of each year and added to an officer's time bank. If an officer is transferred from any other work shift to the 12 hour patrol shift during the calendar year the compensatory time shall be granted on a prorated basis. In addition to the 36 hours of compensatory time any standby patrol officer assigned to the 12 hour shift shall be compensated on a double time pay basis when they are called in for duty while on standby. Detective Bureau would also be compensated if call in to fill in for a squad on an emergent basis.

All other terms and conditions of the prior agreement remain in full force and effect.
